Varian motioned to approve the Resolution to Proceed with Submission of the Question of Levying a Replacement Tax in Excess of the Ten Mill Limitation (Resolution # L2021-02).

B. Contract with Mary Rutan Hospital for emergency admission evaluations:

Nicholl has not received the proposed contract back from MRH as of this afternoon, so Nicholl reviewed the status of the contract with members for informational purposes. Sorensen and Nicholl have been working with law enforcement and the emergency department on the pink slip process and where financial responsibilities lie. Law enforcement has been reluctant to issue pink slips and transport to the ED due to risk of financial liability. Trainings have been sponsored by the Board and presented by Christina Shaynak-Diaz, an attorney and one of the state's leading experts on the process. The Board is proposing covering the costs of indigent residents who have no other source of coverage.

Nicholl will keep the Board updated.
